Textual Information(1)	The Promoter entities Hi-tech Mercantile (India) Pvt. Ltd., Pareek Overseas Pvt. Ltd., Primenet Global Ltd., Spring Mercantile LLP, Techdrive Software Ltd., Vanshi Farms Pvt. Ltd., and Vision Mercantile Pvt. Ltd. have earlier informed that 1797589 shares which were originally held in DP ID 12051900 maintained with GSV Securities Pvt. Ltd. (GSV), were illegally transferred to other accounts without any authorization from them. The Promoter entities have initiated legal actions i.e. FIR with Economic Offense Wing and Arbitration case in CDSL to restore the illegally transferred shares. However, until the arbitration award is granted in favour of promoter entities, the shareholding of said promoter entities are shown as per the holding in their Demat accounts.
Textual Information(2)	1. Promoter entity Aircon Systems (India) Pvt. Ltd. has been removed from the Shareholding Pattern as on 30th September 2025 pursuant to the reclassification approval received on 4th September, 2025. 2. The shares of the Promoter entity, Vanshi Farms Pvt. Ltd., were illegally transferred from its demat account held with GSV Securities Pvt. Ltd. (GSV) without any authorization. The Promoter entity has initiated legal actions i.e. FIR with the Economic Offence Wing and Arbitration case in CDSL to restore the illegally transferred shares. However, until an arbitration award is granted in favour of the Promoter entity, its shareholding is reflected based on the current status of its demat account, which shows a nil balance as on 30.09.2025.
